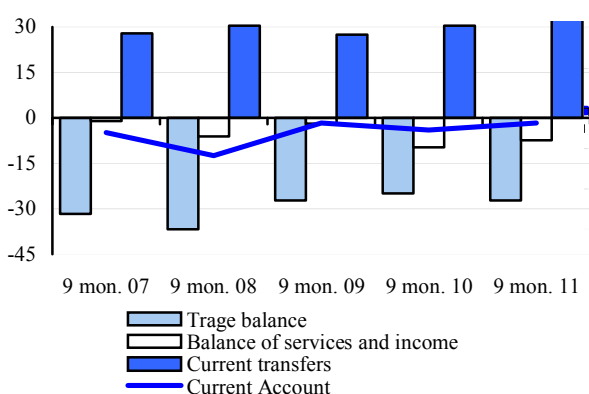
CURRENT ACCOUNT

As per results of nine months of 2011 the **current account balance** was formed positive in the amount of US\$ 86.8 million.

The current account deficit¹ constituted 6.0 percent to GDP or US\$ 68.8 million.

Chart 1: Current Account

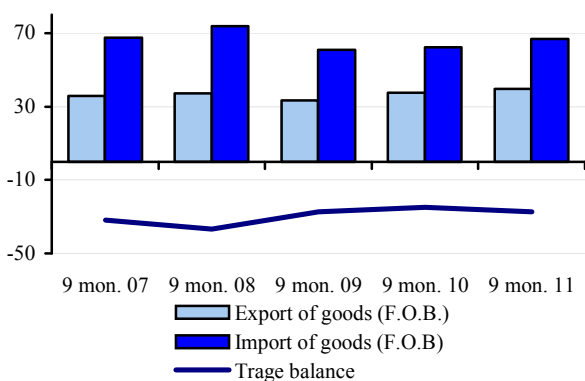
in percent of GDP

TRADE BALANCE²

The **trade balance** deficit of the Kyrgyz Republic for January-September 2011 increased by 40.1 percent as compared to the similar period of 2010 and constituted US\$ 1111.7 million in FOB prices (with regard to estimations of the National Statistics Committee and National Bank of the Kyrgyz Republic). Increase in the size of the negative trade

balance was provided by faster rates of import accumulation as compared to export.

The **external turnover** in FOB prices in January-September 2011 constituted US\$ 4 329.8 million and in comparison with the similar period of 2010 increased by US\$ 1 123.5 million (to 35.0 percent). In the structure of the goods turnover, the share of export constituted 37.2 percent, and the share of import - 62.8 percent.

The export of goods in FOB prices (with regard to estimations of the National Statistics Committee and National Bank of the Kyrgyz Republic) for the reporting period constituted US\$ 1 609.1 million and increased in comparison with the similar period of last year by 33.4 percent. Growth of the total export was provided by supplies of gold, which increased by 74.4 percent (by US\$ 325.0 million). In the reporting period, the export, without regard to gold, increased by 10.1 percent and constituted US\$ 847.0 million. Re-export of oil products to CIS countries in terms of nine months of 2010 increased by 68.7 percent (by US\$ 12.6 million).

According to the functional structure of the export, in the reporting period, there was growth on all items of functional distribution, except for raw materials. The largest category of the export was accounted for intermediate goods (61.8 percent from the total export) and consumer goods (21.9 percent). The share of raw materials decreased by 13.0 percentage point and constituted 4.0 percent from the total export.

Growth of *intermediate goods* constituted 78.5 percent (by US\$ 391.8 million). Cost of intermediate goods export reached the level of US\$ 891.1 million, of which US\$ 762.1 million was provided by supplies

of gold to Switzerland (81.9 percent from the total export volume of gold) and United Arab Emirates (18.0 percent). Increase in the gold export cost was due to growth of prices by 30.8 percent and the volume of production by 33.3 percent.

Export of *consumer goods* in value terms increased by 27.0 percent (by US\$ 67.0 million) and constituted US\$ 315.5 million. This increase was mainly due to supplies of vegetables, which increased by 90.8 percent (by US\$ 29.8 million) compared to the similar indicator of the past year. In addition, growth tendency for export of clothes and accessories, milk and dairy products, fruits and nuts (increase by 15.6, 18.7 and 10.7 percent, respectively). Export of vegetables increased mainly to Kazakhstan by US\$ 19.9 million, whereas, supplies to the Russian Federation decreased by US\$ 1.3 million, and constituted US\$ 11.0 million. Supplies of beans to Turkey increased in 2.5 times to US\$ 16.3 million. Clothes and accessories were mainly exported to Russia (96.1 percent of all similar supplies) for the amount of US\$ 112.7 million.

Export of *energy* products constituted US\$ 134.2 million, which is by US\$ 43.2 million high that in the similar period of the previous year. Increase was due to growth of exports of electric energy to Kazakhstan, the volume of which increased by 74.8 percent (by US\$ 27.4 million). The cost volume of the aviation kerosene increased by 23.7 percent and constituted US\$ 46.6 million. This increase was due to the growth of prices by 16.2 percent and the physical volume by 6.5 percent. In the reporting period, supplies of aviation kerosene increased to Russia (by 65.1 percent) and decrease of the aviation kerosene export to United Arab Emirates by 46.3 percent. Shares distribution of export of energy products to the non-CIS countries constituted 28.3 percent and CIS countries- 71.7 percent.

The aggregate volume of the export of *raw materials* decreased by US\$ 57.1 million as a result of decrease of supplies by 67.7 percent (by US\$ 119.9 million). The negative tendency was provided by the decrease in the volume of production of non-organic chemical substances, the export of the latter within nine month of 2011 decreased to US\$ 16.4 million. In the corresponding period of the past year, the export of

this product constituted US\$ 143.4 million and made up 81.1 percent of the overall export of raw materials. Also, the export of raw materials was affected by decrease in tobacco export to Russia by US\$ 7.1 million.

Export of *investment goods* in the reporting period increased by 74.3 percent and constituted US\$ 44.5 million. In the structure of this category, growth of re-export of flight vehicles and related equipment (by US\$ 7.7 million) and automobiles, not included into other categories (by US\$ 3.3 million) was observed. Shares distribution of export of investment goods to CIS countries and non-CIS countries constituted 81.4 and 18.6 percent, respectively.

Import of goods in FOB prices increased by 36.0 percent and constituted US\$ 2720.7 million.

Main components of import, as before, were consumer goods (38.0 percent of the overall volume of import), intermediate goods (23.1 percent) and energy products (22.1 percent)³.

Import of *consumer goods* increased by 52.5 percent and constituted US\$ 1119.1 million. In the reporting period, there was increase in import of medications by 71.3 percent (by US\$ 46.4 million), mainly, due to the US humanitarian aid in the amount of US\$ 22.7 million. Supplies of wheat flour and mangcorn were increased in 6.9 times (by US\$ 27.3 million), sugar, molasses and honey (by US\$ 22.6 million), coffee, tea, cocoa and spices (by US\$ 15.7 million), essential oils and perfume substances (by US\$ 11.0 million), meat and meat products (by US\$ 5.4 million). At the same time, decrease of the import of fruits and nuts by 10.6 percent and rice by 41.8 percent was noted. Import of clothes and accessories from China

increased in 2.3 times and shoes in 1.5 times. Whereas, physical volumes of import of rice decreased by 65.3 percent, fruits and nuts by 51.6 percent. Import of second-hand automobiles from Japan increased in 2.0 times and from Germany in 1.4 times. Import of chocolate and other cocoa products from Russia increased by 56.6 percent, cereal products, flour and starch increased by 39.4 percent and medications by 32.3 percent. Supplies of wheat flour and madcorn flour from Kazakhstan was increased in 6.8 times (by US\$ 19.7 million), cigarettes containing tobacco by 60.5 percent (by US\$ 7.5 million).

Import of *intermediate goods* in the reporting period increased by 43.1 percent and constituted US\$ 679.9 million. In the reporting period, according to the goods structure of this category, there was increase in supplies of crude iron and steel by 53.6 percent (14.9 percent from the overall volume of intermediate goods), plastic materials in primary form by 65.5 percent, fabric by 51.6 percent, fertilizers by 82.4 percent. At the same time, decrease in the import of aluminum by 15.6 percent was observed.

Within the reporting period, increase of import of rubber tires from Russia by 22.8 percent (US\$ 9.8 million) and Belarus in 5 times (US\$ 6.7 million) was observed. In addition, there was increase in supplies of compressed and remanufactured wood from Russia by 63.6 percent (US\$ 9.8 million). Import of crude iron and steel from Russia increased by 55.7 percent (by US\$ 15.96), from China - by 45.1 percent (by US\$ 9.9 million) and from Kazakhstan - by 73.3 percent (by US\$ 8.6 million). Supplies of fabric from China increased by 51.8 percent (by US\$ 14.8 million) were noted.

Import of *energy products* in the reporting period increased by 12.5 percent and constituted US\$ 651.6 million. The share of oil products in this group of goods constituted 85.7 percent, which were mainly supplied by Russia (91.5 percent of the overall volume of supplies of oil products). The reporting period showed increase in the cost volume of import of the following category of oil products: automobile gasoline - by 40.6 percent (due to the growth of physical volume by 35.8 percent), diesel fuel - by 77.5 percent (due to the growth of prices by 28.6 percent and physical

volume by 38.0 percent) and petroleum residual by 27.8 percent (due to the growth of physical volume by 33.4 percent). Import of aviation kerosene was decreased by 60.9 percent, which was due to the decrease of the natural volume by 70.8 percent amidst growth of prices by 34.0 percent. Import of crude oil in the reporting period stopped at all. Import of coal was decreased by 20.8 percent (by US\$ 5.4 million). Import of natural gas was increased by 25.8 percent due to the growth of prices by 13.5 percent and volume of consumption by 10.8 percent.

Import of *investment goods* in the reporting period increased by 34.9 percent and constituted US\$ 400.7 million. According to the structure of this category of goods, there was a significant increase in import of electric linear telephone and telegraph apparatus (in 2.3 times to US\$ 72.8 million) and automobiles for cargo transportation (by 35.3 percent to US\$ 71.7 million). The main share of imported electric linear telephone and telegraph apparatus falls with China (87.0 percent), whereas, import of automobiles for cargo transportation and special purpose vehicles fall with USA (51.1 percent). Additionally, there was growth of supplies of mechanical shovels, diggers and pay-loaders (in 2.5 times), spare parts and equipment for the civil construction (in 1.6 times) and hand and machine tools (in 1.8 times).

Import of *raw materials* constituted US\$ 92.7 million, which is by 17.7 percent higher of the similar indicator in the past year. The major share of import was provided by the supplies from Kazakhstan which reached the amount of US\$ 74.6 million. There was increase in supplies of un-milled and mangcorn crops by 24.3 percent (by US\$ 9.0 million) in the structure of import of raw materials from Kazakhstan.

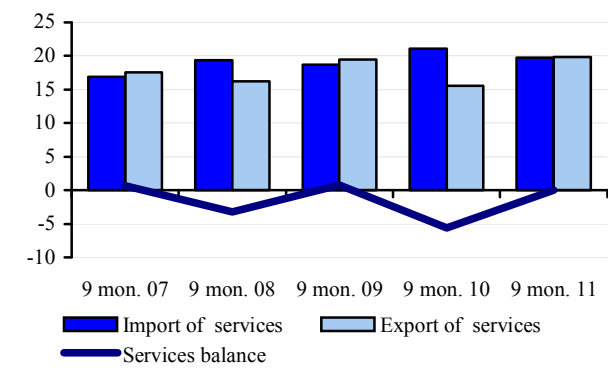
BALANCE OF INTERNATIONAL SERVICES

The turnover of international services based on the results of nine months of 2011 increased by 37.2 percent and constituted US\$ 1 608.9 million.

In January - September 2011, the **balance of international services** was formed positive in the amount of US\$ 1.5 million, whereas, in the similar period of 2010, the balance was formed negative in the amount of US\$ 177.5 million. The index was

formed by the growth of export of services by 61.8 percent. Import of services in the reporting period was increased by 19.0 percent.

According to the results of nine month of 2011, **export of services** was formed in the amount of US\$ 805.2 million. Increase in this indicator is based by the growth of export almost on all types of services: financial services- in 3.1 times, trips - in 2.2 times, construction services - in 1.6 times, other services - by 27.7 percent, business services - 26.9 percent and transport services - by 20.7 percent. At the same time, there is a decrease in the volume of export of insurance services (in 4.4 times), computer and information services (in 2.4 times) and communication services (by 15.6 percent), with the overall share of 2.0 percent.

In the reporting period, export on the item "trips" was amounted to US\$ 453.3 million, which makes up 56.3 percent of the overall volume of the export of services. In addition, there is equal share of increase on the items "business trips" and "personal trips" (in 2.2 times).

Export of "transportation services" was increased by US\$ 126.1 million, which makes up 15.7 percent of the overall volume of export of services. The growth of this indicator is based on the increase of the volume of export of services provided by air and automobile transportation by US\$ 15.4 and US\$ 8.1 million, respectively.

Export of services on the item "business services" constituted US\$ 113.0 million, having increased by

US\$ 24.0 million as compared to the similar indicator of the past year.

Within nine months of 2011 **the import of services** increased by 19.0 percent and constituted US\$ 803.7 million. This increase is explained by the growth on the following items of import of services: other services (in 2.3 times), trips (in 1.5 times), transport services (by 19.9 percent), construction services (by 18.4 percent), communication services (by 13.8 percent) and insurance services (by 9.5 percent). At the same time, within the reporting period there was decrease in the volume of import of services on such a significant item as "business services" by 29.9 percent. Regarding the rest items of import there is decrease in the volume of received services as compared to the nine months of the past year.

Import of *transportation services* was formed in the amount of US\$ 348.1 million, having increased by 19.9 percent against the similar indicator of 2010. This growth was provided by the increase of import of services carried out by the main types of transport: air (by 52.2 percent), automobile (by 45.7 percent) and railway (by 9.4 percent).

The volume of import services on the item "*trips*" increased to US\$ 295.2 million, which is 36.7 percent of the overall volume of the import of services.

Import of services on the item "*business services*" decreased to US\$ 79.5 million, which is by US\$ 32.4 million less than it was in 2010. Nevertheless, this item takes 9.9 percent of the overall volume of import of services January- September 2011.

Within the reporting period there was a significant increase in the volume of received *other services*, which made up US\$ 28.8 million (growth by US\$ 16.4 million).

INCOME

As per the results of nine months of 2011 the negative balance of incomes constituted US\$ 305.9 million, which is in 2.3 times higher than the indicators of the corresponding period of 2010.

The growth of the negative balance of this item is mainly provided by increased incomes of foreign investors from performance of investing activities in

the Kyrgyz Republic. Thus, incomes of direct foreign investors increased in 3.0 times and constituted US\$ 264.8 million, of which reinvestment incomes increased by US\$ 258.4 million (in 2.7 times).

Within the reporting period the negative balance of incomes on "other investments" decreased by 15.0 percent to US\$ 18.6 million.

Negative balance on the item "compensation of employees" constituted US\$ 22.7 million, having remained at the level of the previous year.

TRANSFERS

The balance of **current transfers** on the results of nine months of 2011 was formed with positive balance in the amount of US\$ 1 347.3 million, which is 38.1 percent higher compared to the corresponding period of 2010.

Net inflow of current transfers to **the sector of general government** (standard presentation of the balance of payments) constituted US\$ 66.4 million, which is by 55.5 percent higher of the corresponding indicator of 2010. This increase was mainly due to the growth of cash grants received by the government sector, in particular, from the Asian Development Bank within the program "Emergency assistance for the rehabilitation and reconstruction" (US\$ 23.5 million) and the Government of Turkey (US\$ 10.0 million).

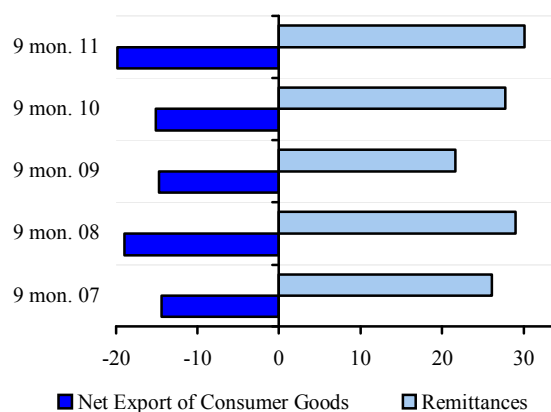
Net inflow of current transfers to **other sectors** (standard presentation of the balance of payment) constituted US\$ 1 280.9 million, having increased by 37.3 percent compared to the similar indicator of the past period. The main share of total revenues is as before accounted for the item "*money transfers of workers*" (95.6 percent), which net inflow within January - September of the reporting year increased by 37.8 percent (by US\$ 385.7 million).

In its case, the biggest share in the gross inflow of *money transfers of workers* falls with the remittances through the money transfer systems⁴ (91.1 percent). Within January -September 2011, net inflow on money transfer systems compared to the

similar indicator of 2010, increased by 38.0 percent to US\$ 1 109.3 million. At that, geographic structure of money transfers still remained unchanged. According to the results of nine months of 2011 the main share of money transfers was from the Russian Federation (93.9 percent), Kazakhstan (2.4 percent) and USA (2.3 percent). The main outflow of money transfers was to the Russian Federation (97.1 percent).

in percent of GDP

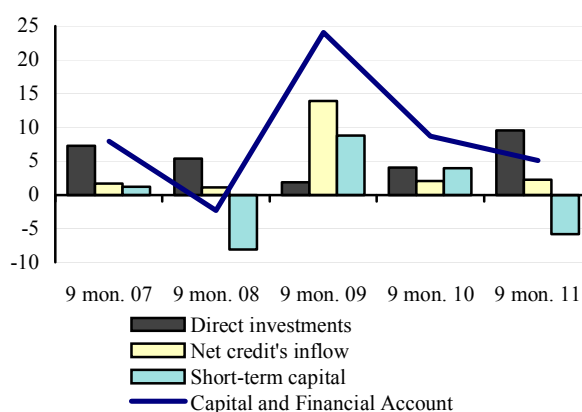


The balance of money transfers still covers the net export of consumer goods, which in turn was formed with the deficit in the amount of US\$ 803.6 million.

CAPITAL AND FINANCIAL ACCOUNT

As per the results of nine months of 2011, **the balance of capital and financial transactions** was formed positive in the amount of US\$ 208.4 million, which is less by 24.8 percent than the corresponding index of nine months of 2010.

Deficit in the **account of capital transactions** within nine months of 2011 was decreased by 24.4 percent to US\$ 35.0 million. Decrease in the deficit is mainly connected with the rehabilitation of goods grants to the government sector in the amount of US\$ 18.5 (item "capital transfers") and decrease in the movement of the capital of migrants, moved abroad for permanent residence by US\$ 7.8 million (item "other sectors").

Positive balance **in the account of financial transactions** decreased by 24.7 percent and constituted US\$ 243.4 million.

As per the results of nine months of 2011 the inflow of direct investments to the Kyrgyz Republic constituted US\$ 388.7 million, having increased in 3.0 times as compared to the similar period of 2010. The main inflow in the structure of direct investments was on the volume of undistributed income from direct investment.

Increase in the net inflow of direct foreign investments is mainly due to the investments from the following countries: Canada (US\$ 219.5 million), China (US\$ 54.9 million), Great Britain (US\$ 32.3 million) and Kazakhstan (US\$ 7.3 million).

According to the types of economic activity, the inflow of investments was mainly in the manufacturing industry for the amount of US\$ 219.3 million, in operations with the real estate - US\$ 57.9 million, in financial activity - US\$ 44.2 million and in trade- US\$ 40.8 million.

The item "portfolio investments" within the reporting period was formed with the negative balance in the amount of US\$ 88.4 million, whereas the corresponding indicator of nine months of 2010 was formed positive in the amount of US\$ 103.1 million. Within the reporting period there was increase in the volumes of transactions of the residents with debt securities in the amount of US\$ 93.9 million.

As per the results of nine months of 2011, the item "other investments" was formed with deficit in the amount of US\$ 56.8 million, against the net surplus of US\$ 89.3 million in the corresponding period of 2010. Changes in this item were mainly due to a big volume of financial transactions performed by the residents on the acquisition of foreign assets against similar transactions of non-residents on purchase of assets in the Kyrgyz Republic.

Within the reporting period there was increase in the assets of residents in foreign countries by US\$ 152.0 million. Growth of assets was provided by significant accumulation of monetary fund's by the enterprises in foreign accounts in the amount of US\$ 99.8 million and increase in the accounts receivables by US\$ 26.7 million.

Liabilities to the "outside world" within nine months of 2011 were increased by US\$ 95.2 million.

Net inflow of credit capital into the government and private sector of the economy achieved US\$ 89.7 million. The main volume of the net inflow of credits within nine months of 2011 constituted US\$ 187.6 million, having remained at the level of the corresponding period of 2010, whereas payments of the principal amount of credits was decreased by 14.2 percent to US\$ 97.9 million.

It should be noted that within the reporting period performance of financial obligations by the Kyrgyz Republic on servicing the government external debt was made in full scope and on time.

Accounts receivables of enterprises to non-residents as per the results of nine months of 2011 increased by US\$ 9.8 million against the negative tendency, which was formed within nine months of 2010 in the amount of US\$ 5.6 million.

The item "**Errors and omissions**" was formed with negative balance in the amount of US\$ 52.7 million,

which demonstrates the undercount of operations related to outflow of capital from the republic or undercount of import of goods and services.

The volume of **gross international reserves** as per the end of the reporting period constituted US\$ 1 845.8

million, which is by 9.6 percent higher than the corresponding indicator of nine months of 2010. Coefficient of coverage with gold and foreign exchange reserves of future import of goods and services constituted 4.2 months.

Chart I.1. Exchange Rate and the Real Effective Exchange Rate Index

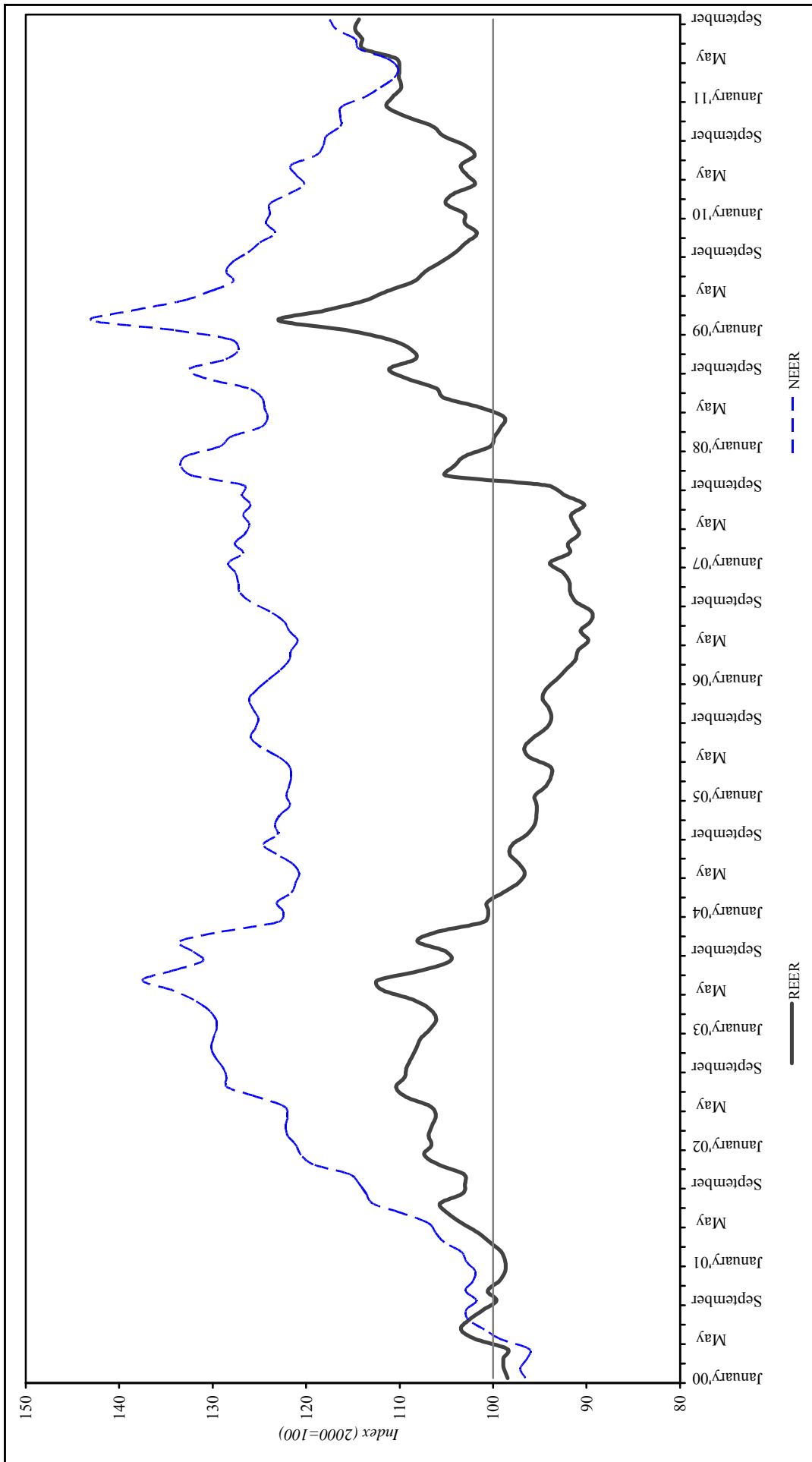
