Review of inflation in the Kyrgyz Republic contains a description of inflation developments by components in the regional context, and, in general, the analysis of inflation factors and the inflation forecast for the forthcoming quarter. It is published on the quarterly basis in Kyrgyz, Russian and English.

Banking System Development Trends

The purpose of the “Banking System Development Trends” is to study and assess development of the banking system in Kyrgyzstan, as an official intermediary, to identify obstacles to achievement and maintenance of stability, as well as to estimate elements of stability in the banking system of Kyrgyzstan. It is published as of January 1 and July 1 in Kyrgyz and Russian.

Statutory Acts of the National Bank of the Kyrgyz Republic

The goal of the publication "Statutory Acts of the National Bank of the Kyrgyz Republic" is to officially publish the statutory acts of the National Bank to furnish the commercial banks and the public with the normative documents of the National Bank and official information about performance of the National Bank, as well as to promulgate the banking legislation of the Kyrgyz Republic. Assumptive periodicity of the journal is to publish once a month in Kyrgyz, Russian and English.

Press Release of the National Bank of the Kyrgyz Republic

Press Release of the NBKR contains a chronicle of events in the National Bank and the financial market basic data. It is published on a weekly basis in Kyrgyz and Russian.

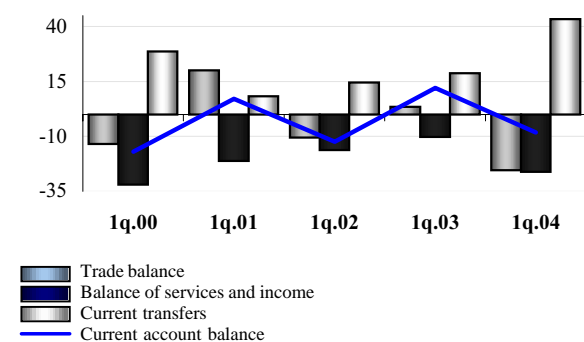

1. RECENT DEVELOPMENTS

The overall **balance of payments of the republic** was practically balanced in the accounting period (US\$0.1 million). However, the current account developed as negative as against its positive value in the similar period of the last year. The current account deficit of US\$8.2 million was minus 2.3 percent of GDP, whereas in the similar period of 2003 the current account had the positive balance of US\$12.0 million or 3.9 percent of GDP. The current account deficit in the accounting period was due to, mainly, substantial growth of the negative balance of income and the trade deficit.

millions of US dollars

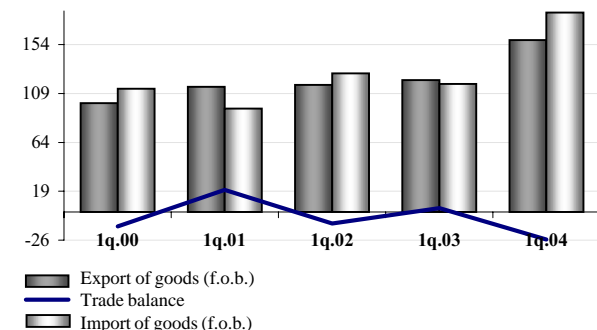


Data on international services for 1q. of 2004 are preliminary

Foreign trade operations that resulted in rates of growth of import of goods outstripping the rates of growth of their export determined negative development of foreign trade balance. The **trade deficit** for January to March of 2004 made US\$ 25.5 million as compared to the positive balance of foreign trade totaling US\$3.4 million in the corresponding period of 2003.

At the same time, the **foreign trade turnover** increased by 43 percent and made US\$341.9 million. The foreign trade turnover with the CIS countries increased by 61.7 percent, with the non-CIS countries - by 28.5 percent.

The **export turnover of goods** increased by 30.4 percent in comparison with the first quarter of 2003 and made US\$158.2 million according to the results of the first three months of 2004.

One of the principal causes of growth of the volume of exports of goods was that of the increase in export deliveries of gold, which made US\$67.3 million for the accounting period, that exceeds a corresponding parameter of the last year by 25.6 percent. The increase in the price of gold from US\$357 to US\$405.6 for one Troy ounce was the major factor, which determined growth of export of gold in terms of value.

At the same time, export of goods excluding gold also increased by 34.3 percent, having thus reached a level of US\$90.9 million. One of the factors that had its impact on this growth was that of the increase in deliveries to foreign markets of such goods, as glass, garments, sugar, and scrap metal. As a whole, the basic items of export of goods that made in the accounting period 95 percent of the turnover of exports of goods showed growth of physical deliveries to 58 percent, with a reduction in the export price by 19 percent, and in terms of value the volume of export of these goods increased by 29 percent.

In a geographical structure of export among the CIS countries Russia and Kazakhstan traditionally prevail. The export turnover with these countries increased by 27.3 and 69.5 percent and according to the results of the quarter under consideration made US\$30.5 and US\$13.4 million. External deliveries to the United Arab Emirates, whose cumulative shares in the turnover of exports made 43.2 percent or US\$67.9 million.

Import of goods¹ at f.o.b. prices increased by 55.9 percent and made US\$183.7 million. Significant growth of imports was noted in operations with the CIS countries (by 76.9 percent), whose basic fell on the increased purchases of mineral oil, in particular, jet fuel and vehicle gasoline, mainly, from Russia and Kazakhstan.

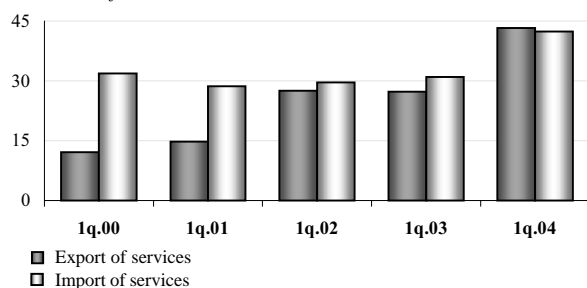
The largest items of import in the first quarter of 2004 were those of consumer goods and energy resources, whose shares made 34.7 and 30.6 percent, correspondingly. Growth of the volumes of consumer goods was due to the increased inflow of such goods, as pharmaceutical products, fabrics, sugar and vehicles. Besides growth of import of spare parts of machines and equipment, rolled ferrous metals and asbestos in the accounting period caused the increase in the volume of imports of non-capital items to US\$28.0 million (as against US\$17.8 million in the similar period of 2003).

The geography of import deliveries was as follows. The share of import from Russia among the CIS countries was the largest one (31 percent) and made US\$60.7 million. Deliveries of goods from Kazakhstan increased from US\$25.3 to US\$38.5 million. Among the non-CIS countries the basic suppliers of goods, as before, were China, USA, Germany and Turkey.

The first quarter of 2004 was characterized by the positive balance of services totaling US\$0.8 million² caused by outstripping rates of growth of export of services (for comparison: in the first three months of 2003 the negative **balance of international services** was registered at US\$3.7 million). As a whole for the accounting period the external turnover of services increased by 40 percent and made US\$81.6 million.

Data on international services for the first quarter of 2004 are preliminary.

According to the results of the considered period, the volume of services rendered to non-residents increased from US\$27.3 to US\$43.2 million. The basic growth fell on the services classified under the item "Trips". As a result of improved statistical coverage, export of services under the given item

increased more than three and a half times and made US\$19.2 million, corresponding to 44 percent of the turnover of export of services. At the same time, the share of transport services decreased from 29 to 21 percent. However, in terms of value, the volume of exports of this kind of services increased by 14 percent and made US\$9.2 million. As during the previous periods, the prevailing were the air and railway transportation services that made US\$5.5 and 2.4 million, correspondingly. The turnover of other services rendered to the non-residents for three months of 2004 also increased by 8 percent and made US\$14.9 million.

Import of services in the accounting quarter exceeded the parameter of the base period by 36.8 percent and reached the level of US\$42.4 million. In import of services, the transportation services, whose volume increased by 52.7 percent, continue to play a dominating role, having thus reached the level of US\$16.9 million (or about 40 percent of the turnover of import of services). However, the most essential impact on growth of import of international services was that of the increase in the volume of services received by the residents and reflected under the item "Trip". The volume of import of these services grew from US\$1.9 to US\$10.1 million, that also speaks for, first of all, an improvement of statistical coverage. The turnover of import of other services was reduced by 23.8 percent and made US\$9.9 million, being, mainly, caused by the decrease in import of construction and business services. The volume of technical assistance remained at the level of the first quarter of 2003 and made US\$5.1 million.

In comparison with the corresponding period of the last year, the negative **balance of income** increased more than four times in the first quarter of 2004. The deficit of the balance of income made US\$26.9 million against US\$6.5 million the year earlier. One of the main reasons of its developments was that of substantial growth of reinvested income from direct investments and that of essential growth of the volume of interest payments on foreign loans.

The volume of reinvested income from direct investments also increased from US\$1.4 million to US\$15.8 million. As a result, the negative balance of income for the first three months of 2004 made US\$16.4 million against US\$2.1 million in the corresponding period of the last year. At the same time, income from debt, represented by interest payments on credits received as direct foreign investments, was reduced by 29 percent and made US\$0.5 million.

The negative balance of income from other investments also increased from US\$1.4 to US\$7.9 million that was the result of growth of interest payments on foreign loans. The volume of payments as repayment of interest on the credits attracted to the economy of the republic grew more than five and a half times and made US\$8.2 million. Payments on foreign loans of the private sector of the economy increased from US\$0.1 to US\$5.1 million, of which US\$4.9 million was the share of payments directed to repay interest on credits, involved under the gold mining project.

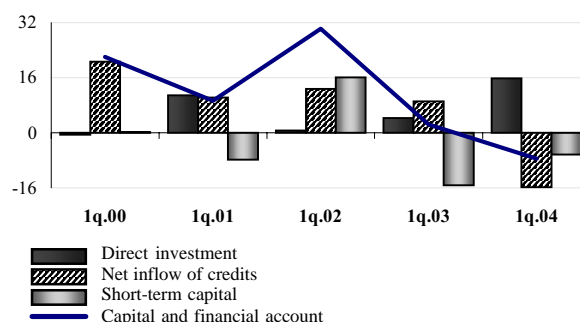
Other items of the balance of income showed the developments either. For instance, the reduction in the positive balance under the item "Incomes from Portfolio Investment", which made US\$0.1 million for the analyzed period and it is by 43 percent less than the similar indicator in of the corresponding period of 2003. The negative balance under the item "Compensation of Labor" decreased by 13.6 percent and made US\$2.7 million.

The positive balance of **current transfers** for the first quarter of 2004 made US\$43.4 million (this parameter in the first three months was equal US\$18.8 million last year). Thus the positive balance under all basic items of current transfers increased. For instance, the volume of net inflow of official transfers grew almost twice and made US\$12.9 million. At the same time, growth was noted as a result of the increase in the inflow to Kyrgyzstan cash grants, as well as the grants as goods. Receipts of grants in cash, directed to financing of the state budget deficit, increased from US\$1.5 to US\$4.8 million and were given by the Commission of the European Community. The size of humanitarian aid, received by the public sector of the republic, was US\$8.3 million as compared to US\$1.9 million one year earlier. The flows of private capital, classified as the current transfers, showed in the accounting quarter the net inflow of US\$30.5 million, that almost twice exceeds the parameter of the base period. The transfers of individuals had the determining impact.

According to the results of the first three months of 2004, the deficit of the **capital and financial account** was registered at US\$ 7.5 million, whereas in the comparable period of 2003 the positive balance was noted at US\$2.4 million. At the same time, the accounting period was characterized by the capital account deficit of US\$1.1 million, while the financial account deficit was US\$6.4 million.

The negative balance of the capital account was due to the reduction in the receipts of investments goods on a gratuitous basis and the increase in the net outflow of capital connected to migratory processes. The net inflow of capital transfers as goods in the accounting period decreased by US\$2.7 million and totaled US\$1.1 million. The net outflow of another component - transfers off migrants increased, on the contrary, by 57.7 percent and reached the level of US\$7.3 million.

The analysis of the structure of the **financial account** showed that in the first quarter of 2004 there was the net inflow of capital on direct and portfolio investments. The items "Other Investment" and "Financial Derivatives" showed growth of the negative balance.

The positive balance under the item "**Direct Foreign Investment**" increased from US\$4.2 million in January to March 2003 to US\$15.8 million in the first quarter of 2004. Growth was noted in the net inflow of direct foreign investments as reinvested income that testifies to macroeconomic stability in the republic and growing trust of private foreign investors. The volume of profit received by the non-residents and reinvested to the economy of the republic as part of projects made US\$15.8 million for the accounting period against US\$1.4 million in the base period. However, investments in equity capital were characterized by the net outflow of capital that almost tripled and made US\$3.5 million according to the results of the accounting quarter of 2004. The volumes of direct foreign investment into other capital of enterprises - residents of Kyrgyzstan were reduced by 14.2 percent and made US\$3.5 million.

The net volume of attracted **portfolio investments** was reduced by 36.7 percent and made US\$7.0 million. At the same time, as a result of operations with foreign securities, the reduction in foreign assets of residents was noted at the level of US\$7.0 million.

Owing to low interest of non-residents in domestic securities (in view of the shallow and weak securities market in Kyrgyzstan), foreign liabilities on this type of investments did not change.

Fluctuations of the price of gold in the world markets determined growth of the negative balance of **financial derivatives** from US\$5.3 to US\$6.0 million.

The item "**Other Investment**" showed the negative balance in the volume of US\$23.2 million for the first quarter of 2004 and it was by US\$11.3 million more in comparison with the corresponding period of 2003. At the same time, the reduction by US\$6.6 million was noted in foreign assets against their growth in the base period by US\$ 32.4 million. The reduction in the foreign assets is, basically, connected to the reduction of debtor indebtedness and foreign assets on the accounts of enterprises abroad (by US\$18.1 and US\$8.0 million, correspondingly). Assets of commercial banks increased by US\$19.5 million, that was, mainly, due to the operations with foreign exchange in cash and deposits.

The accounting period was characterized by the decrease in foreign liabilities by US\$29.8 million whereas the year earlier this item showed growth

of US\$20.5 million. The essential reduction of liabilities in the considered period was caused by the net outflow of capital due to observance of liabilities on credits, which made US\$ 15.8 million. The latter was, in turn, caused by the significantly increased volumes of amortization payments on foreign loans of the private sector of the economy. Another component that had the essential impact on formation of the negative balance under the item "Loans" was that of the reduction in creditor indebtedness. According to the results of the accounting quarter, US\$23.2 million reduced the debts of Kyrgyz enterprises to the non-residents for goods and services.

The Item "**Errors and Omissions**" for January to-March of 2004 developed as positive of US\$ 15.8 million testifying to under-accounting of trade operations and financial flows.

Thus, according to the results of the first quarter of 2004 **the balance of payments of the Kyrgyz Republic** developed as positive of US\$0.1 million. The volume of total international reserves increased by US\$16.2 million and at the end of the accounting period made US\$401.0 million that covers 5.5 months of import of goods and services.

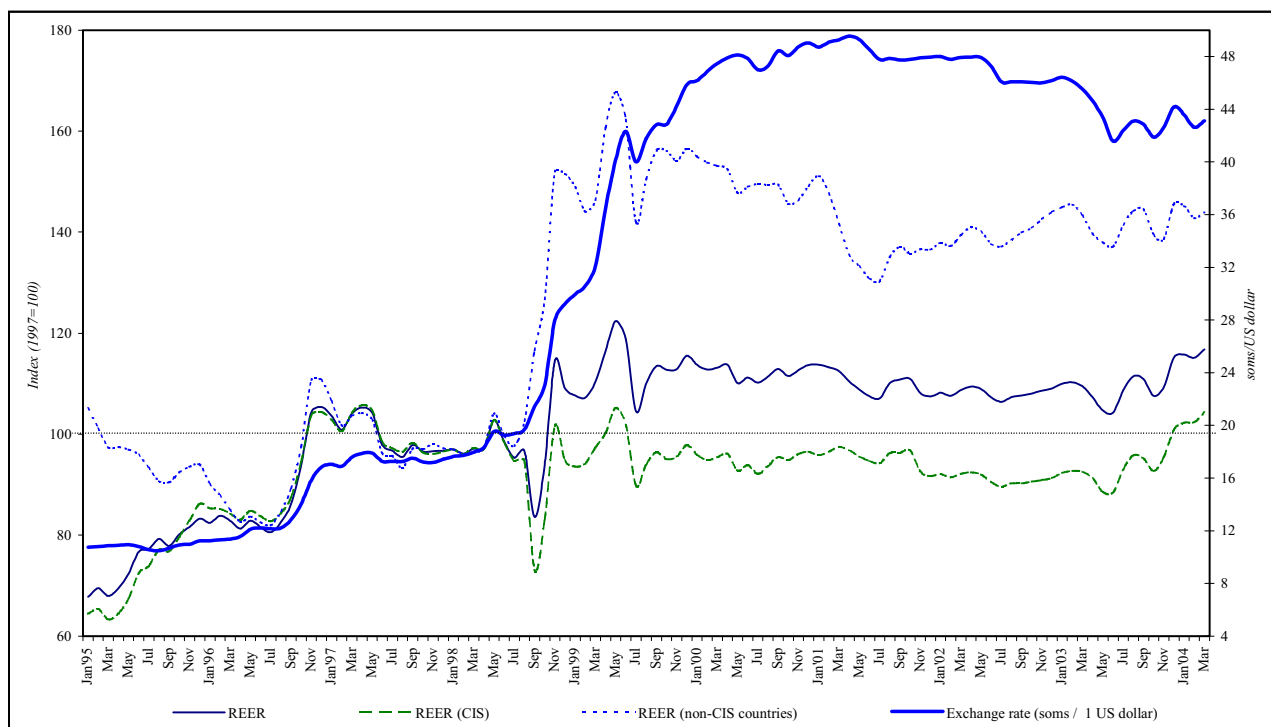
