## ***Balance of Payments of the Kyrgyz Republic***

"Balance of payments of the Kyrgyz Republic" is issued by the National Bank of the Kyrgyz Republic. The legislative basis for the balance of payments are the Law of the Kyrgyz Republic as of July 29, 1997 No. 59 "On the National Bank of the Kyrgyz Republic" and the Resolution of the Government of the Kyrgyz Republic as of November 3, 2000 No. 645 "On measures to improve statistics of the balance of payments of the Kyrgyz Republic". This document reflects last tendencies in external sector development and shows statistical data on the balance of payments, external trade, international reserves, external debt and international investment position, as well as construction methods of balance of payments and informational database. This document is published 4 times a year in January, May, July and October and has 3 language versions: Kyrgyz, Russian and English.

***The data from 2011 to 2015: on foreign direct investment to the country and abroad; on the accounts receivable and the accounts payable; on the accounts of enterprises abroad and the loans issued abroad were revised in the present publication due to improvement in the statistical coverage and clarification of methods. Moreover, the data on the international reserves of the National Bank of the Kyrgyz Republic were revised in accordance with the IMF methods, which stipulate that only the assets in the convertible currencies can be included in the international reserves assets. The assets in other currencies are presented as other assets in the item "other investments". The data for 2015 on the direct, portfolio and other investments are preliminary. The base period used for calculation of the real effective exchange rate was revised.***

The purpose of the document is to publish statutory acts of the National Bank in order to provide commercial banks and public with statutory acts and official information on the National Bank activity, as well as propaganda of the Kyrgyz Republic banking legislation. Presumable publication frequency is once a month in Kyrgyz and Russian languages.

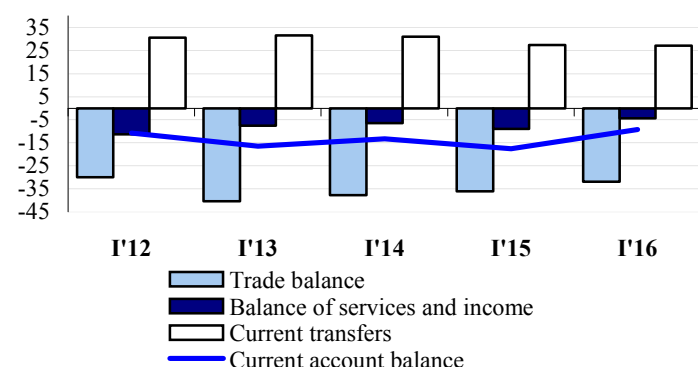

## THE CURRENT STATE OF THE BALANCE OF PAYMENTS

**Chart 1. Current account***(in percent to GDP<sup>2</sup>)*

According to the results of the first quarter of 2016, the current account deficit<sup>1</sup> formed at the level of 9.2 percent to GDP<sup>2</sup> or USD 166.0 million against a decrease in the negative balance of goods and services and an increase in the money transfers.

**TRADE BALANCE**

According to the results of the first quarter of 2016, increase in the deficit of trade balance was due to an outrunning dynamics of decline in exports as opposed to the decline of imports.

**Chart 2. Trade balance of the Kyrgyz Republic***(in percent of GDP)*

Negative **trade balance**<sup>1</sup> of the Kyrgyz Republic in FOB prices in January-March 2016 was formed in the amount of USD 367.8 million, having increased by 6.6 percent as compared to the similar indicator of 2015. Meanwhile, the ratio of the trade balance to GDP decreased from 36.6 percent to 31.9 percent in the reporting period.

**The external trade turnover** in FOB prices in the reporting period decreased by 18.8 percent and constituted USD 1 098.4 million.

**Export of goods in FOB prices** was formed in the amount of USD 365.3 million, having decreased by 27.4 percent as compared to the similar indicator of January-March 2015. **The export excluding gold** in the reporting period constituted USD 266.0 million, having increased by 7.6 percent as compared to the corresponding indicator of 2015.

**The export excluding gold and the NBKR additional estimates** increased by 34.2 percent<sup>3</sup> and constituted USD 247.9 million.

The export cost of the item "goods and operations not included in other SITC sections" decreased by 61.2 percent, primarily due to a reduction in the supplies on major item – gold. As a result, the specific weight of this section decreased by 21.0 percent and constituted 45.1 percent. The export value of other sections changed insignificantly against significant decline in the export of the goods from this section. A decrease in the export of major items from the sections "miscellaneous manufactured articles", "crude materials, inedible, except fuels" and "mineral fuel, lubricants and similar materials" conditioned a reduction of their specific weights in the total structure of exports by SITC sections. An increase in the specific weight of the group "manufactured goods classified chiefly by material" was due to growth in the supplies of iron and steel, whole bovine skin leather.

Despite the decline in the supplies, the most significant volumes of export in the reporting period traditionally fell on the products of **manufacturing industry** (metallurgical, textile and garment industry) and **agriculture**. In January-March 2016, the decrease in the production of basic metals and manufactured metal products by 46.7 percent as compared to January-March 2015 was due to significant reduction of the precious metals production<sup>4</sup>. This factor affected the decline in the value of gold exports by 37.8 percent<sup>5</sup>. The decline in the value of gold exports was due to the reduction in the physical volume by 59.6 percent and the fall in the contractual prices by 4.1 percent<sup>6</sup>. In general, decrease in the value was observed on all goods items of the group excluding "iron and steel", on this item growth made USD 2.6 million.

The reduction in the output of the textile industry and clothing manufacture by 6.0 percent<sup>7</sup> and a decline of consumer demand in the countries importing these goods due to general slowdown of the economic growth in the countries - major trading partners resulted in a decrease of exported clothes and clothing accessories by 59.6 percent. In the reporting period, there was a decrease in exports on all items of the group. Meanwhile, the most significant decline in the supplies was observed on the item "articles of textile fabrics for women and girls" (by USD 6.8 million).

Despite growth in gross output of the agricultural products in January-March of the current year due to increased production in the livestock sector, there was a significant reduction in the exports of livestock and crop production during the reporting period. A decrease in the value was observed on all major items of this section, excluding the item "vegetables". The reduction in the value of supplies was due to a decline in the physical volume of supplies and a decrease in the contractual prices for exported goods.

The specific weight of the non-CIS countries (48.5 percent) prevailed in the geographic structure of export. Switzerland remained the most significant trade partner despite a decline in its specific weight down to 20.1 percent. Moreover, Turkey, the United Arab Emirates and China were significant trade partners from the non-CIS countries. The precious metals and agricultural products were primarily supplied to these countries.

The gross share of the EEU countries in the total volume of exported goods increased up to 39.3 percent. The structure of goods exported to the EEU countries was presented by the textile industry products and the agricultural products. In terms of the EEU individual countries, the Russian Federation and the Republic of Kazakhstan are the main consumers of domestic exported goods.

In general, the Kyrgyz Republic exported goods to 67 countries in the reporting period (in January-March 2015 the export was carried out to 64 countries).

**Import of goods** in FOB prices according to the results of January-March 2016 constituted USD 733.1 million and decreased by 13.6 percent as opposed to the similar indicator of 2015.

In January-March 2016, significant decline in the supplies of items from the section "mineral fuels, lubricants and similar materials" was observed in the **goods structure** of import. As a result, the specific weight of this group decreased by 15.2 percentage points and constituted 12.2 percent. The oil products are the most significant item in this group. In the reporting period, imports of the oil products decreased by 66.6 percent, down to USD 63.4 million, primarily due to a decline in the supplies of the major items of the group – motor spirit and gas oil. In the first quarter of 2016, a decrease in the value of exports of the oil products as opposed to the corresponding indicator of 2015 was due to a decline of the contractual prices by 41.7 percent and a decrease of the physical volumes by 42.8 percent.

In the goods structure of import by the SITC sections in the reporting period the largest specific weight fell on the section "miscellaneous manufactured articles" (18.9 percent). In January-March 2016, the value of the imported items of this section increased by USD 69.3 million. This dynamics was primarily determined by the growth of imported clothes, clothing accessories and footwear from China. An increase in the value was observed on all major imported items of the group, excluding the item "baby carriages, toys, games and sports goods", a decrease of the imports on this item made USD 5.4 million.

The supplies of the commodity group "machinery and transport equipment", the specific weight of which constituted 18.3 percent of the total volume of imports, decreased by 20.0 percent. In the goods structure, the most significant reduction was observed on the item "motor vehicles for the transport of goods and special-purpose motor vehicles" and "moving, extracting or boring machinery".

The specific weight of the industrial products classified by the type of material increased by 1.9 percentage points and constituted 17.2 percent of the total volume of imported goods. In the goods structure of this sections, the most significant changes were observed on the item "iron and steel" (a decrease by USD 28.3 million) and "fabrics, woven of man-made textile materials" (the total import on this item constituted USD 33.2 million, which is by USD 26.5 million more as compared with the first quarter of 2015).

In general, a decrease of the value due to a reduction of the physical volume of imports and import prices was observed on the majority of goods from this group.

**In the geographic distribution** of imports, the specific weight of the non-CIS countries increased by 51.8 percent (up to USD 402.7 million) due to increase in the supplies of consumer goods. Significant growth of imports was observed on the items "articles of apparel" and "footwear". Growth of fabric supplies was observed in the structure of goods imported from the non-CIS countries, as well as a decrease in the imports of such items as "motor vehicles", "iron and steel" and "medicaments". China, the specific weight of which in the reporting period constituted 63.9 percent of the total volume of exports, remained the key trade partner of the Kyrgyz Republic among the non-CIS countries.

The specific weight of the goods supplied from the EEU countries constituted 45.1 percent. Traditionally, the fuel and energy products were primarily imported from the EEU countries in the reporting period. The Russian Federation was the main supplier of oil products. Besides oil products from the EEU countries, an increase was observed in the supplies of consumer goods.

In general, the import to the Kyrgyz Republic in the reporting period was carried out from 110 countries of the world (in January-March 2015 – from 117 countries).

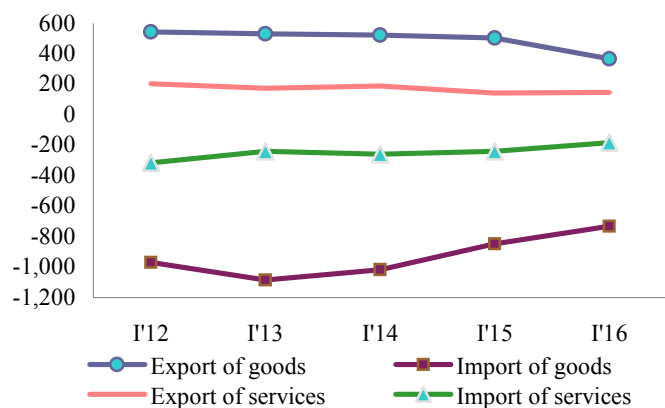

**Chart 3. External service and goods trade\***

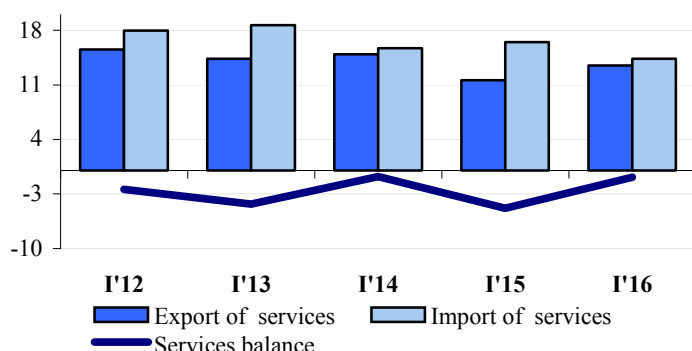

In the reporting period, the balance of transport services as before was found negative and constituted USD 38.4 million, which is by 49.2 percent lower than the same indicator of the first quarter of 2015. At the same time, there was an increase in the export of transport services by 2.9 percent (due to increase in the aircraft transport services), whereas, the volume of import transactions decreased by 33.0 percent (due to increase in the railway transport services).

Net export of business services within the reporting period was found positive and constituted USD 14.3 million, having decreased by 2.6 percent as compared to the indicator of 2015. The main factor that affected the decrease in the import and export of business services in the reporting period was the reduction in the volume of the consultation services.

### INCOMES

Dynamics of the item "incomes" was defined mainly by the change in the volume of incomes on direct investments in the reporting period.

According to the results of the first quarter of 2016, the balance of the item "incomes" was negative in the amount of USD 65.1 million, which is by 34.8 percent lower than the similar indicator of 2015. This tendency is mainly a result of reduction in the volume of re-invested income of the entities from USD 76.5 million to

According to the results of the reporting period of the current year, the turnover of international services decreased by 13.7 percent and constituted USD 330.4 million.

At the end of the first quarter of 2016, **balance of international services** was negative and constituted USD 36.1 million against USD 95.8 million in the corresponding period of 2015. At the same time, there was a decrease in the import of services by 23.4 percent, whereas the volume of services provided by the residents of the Kyrgyz Republic to non-residents increased by 2.5 percent.

In the reporting period the **export of services** constituted USD 147.1 million, which corresponds to 40.3 percent from the volume of export of goods. **Import of services** was in the amount of USD 183.3 million, which constituted 25.0 percent from the import of goods.

In the first quarter of 2016, the main services were as before travels, transport and business services, which in total constituted 81.3 percent of the turnover of international services.

According to the results of the reporting quarter of the current year, the balance of the item "travels" was negative and amounted to USD 12.2 million, which is by 2.1 percent higher

USD 12.9 million. The volume of distributed income of the resident-entities in the form of dividends in favor of foreign direct investors increased and constituted USD 34.2 million.

In the reporting period, the volume of interest payment on the previously received loans increased insignificantly and constituted USD 20.5 million. The volume of incomes received by the residents of the country on other investments in the first quarter of 2016 increased and constituted USD 6.7 million. In general, this contributed to the decrease in the deficit of the item "incomes on other investments" by 20.9 percent (to USD 13.8 million).

According to the results of January-March 2016, the balance of the item "remuneration" was found negative in the amount of USD 4.1 million and decreased by 14.1 percent, which resulted mainly from the decrease in the aggregate volume of non-resident income from labor activities in the Kyrgyz Republic.

## TRANSFERS

The volume of revenues on the item "current transfers" increased, which has become the result of growth in the net inflow of remittances of labor migrants.

Positive balance of **current transfers** according to the results of 2016 constituted USD 303.0 million, having increased as compared to the similar level of 2015 by 30.9 percent.

The impact on the current transfer account was made by **official** and **private transfers** (other sectors), the net inflow of which increased by 10.6 times and by 15.4 percent, respectively.

In the structure of private transfers, as before, the main value have the workers' remittances, the specific weight of which in the gross volume of private transfers constituted 96.5 percent. According to the results of the first quarter of 2016, increase in the net inflow of remittances was due to the increase in the gross inflow thereof by 6.8 percent, meanwhile, the outflow of remittances decreased by 16.1 percent.

The money transfer systems<sup>8</sup> remain the main mode of labor migrants<sup>9</sup> remittances to the country. In the first quarter of 2016, the net volume of funds received from the money transfer systems constituted USD 230.9 million<sup>9</sup>, which is by 15.9 percent higher than the similar indicator of 2015. The geographic structure of remittances remains almost unchanged.

According to the results of the reporting period, the main share of money transfers was received from the Russian Federation (96.4 percent). The specific weight of other countries is significantly low: 2.0 percent of remittances were received from the USA, 0.2 percent – from the Republic of Kazakhstan. In the structure of remittances made from the Kyrgyz Republic, the prevailing specific weight also falls on the Russian Federation (98.7 percent).

Money transfers remained the source of financing the trade deficit. The balance of transfers still covered net export of consumer

goods, which in turn formed with a negative value of USD 210.9 million.

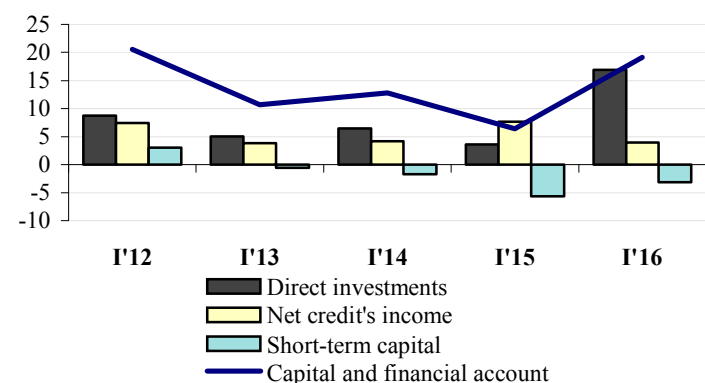
In the first quarter of 2016, the balance of current transfers in the **sector of state governance** was found positive in the amount of USD 40.1 million, which is by 10.6 times higher than the corresponding indicator of 2015. Increase in the inflow of official transfers was mainly due to the growth in the volume of grants received by the state sector. In the reporting period, the volume of paid membership fees to the international organizations increased by 34.5 percent and constituted USD 1.3 million.

## CAPITAL AND FINANCIAL TRANSACTIONS ACCOUNT

*In the first quarter of 2016, the capital and financial transactions account was positive. Inflow of direct foreign investments and decrease in the volume of residents' assets abroad made main influence on formation of the reviewed account.*

**Positive balance** of the capital and financial transactions account was formed in the amount of USD 409.9 million against negative value in the amount of USD 99.1 million in the first quarter of 2015.

**The capital transactions account** was formed in the amount of USD 18.5 million, which is twice higher than the level of the same period in 2015. Increase in the indicator of the reporting period was due to the growth of capital transfers received in the form of grants.

**Financial account**<sup>10</sup> according to the results of the reporting period was formed with a positive balance in the amount of USD 391.4 million, against a negative value in

the amount of USD 108.7 million in the first quarter of 2015. The major inflow of capital in the reporting period was observed on the items "direct investments" and "other investments".

According to the results of the first quarter of 2016, the net volume of funds on the item "direct investments" constituted USD 116.9 million (16.9 percent to GDP<sup>11</sup>) due to positive inflow of currency on the item "other capital". In the reporting period, net inflow of reinvested incomes decreased by 83.1 percent and constituted USD 76.5 million.

In the reporting period, by types of economic activity the highest inflow of direct investments to the country was observed in the entities that deal with the financial intermediation and insurance, professional, scientific and technical activity, manufacturing industry and construction. In the geographic structure of direct investments, net inflow of the capital from China, Russia and Turkey prevail.

According to the results of the first quarter of 2016, the net volume of funds on the item "other investments" was formed positive at the level of USD 274.4 million as opposed to negative value in the amount of USD 75.9 million in the first quarter of 2015, primarily due to the reduction in the volume of residents' assets abroad.

In the reporting period, the volume of residents' foreign assets decreased by USD 309.1 million. Decrease in the assets was observed on all items of "other investments": assets of the commercial banks in the form of cash and deposits decreased by USD 77.0 million, meanwhile, in the first quarter of 2015, the volume of these assets increased by USD 48.2 million; accounts receivable decreased by USD 82.6 million; enterprises' funds in the accounts of the foreign banks decreased by USD 35.6 million.

Moreover, liabilities on "other investments" decreased by USD 34.7 million in the reporting period. This trend was primarily due to increase in the servicing of previously received loans of the public and private sector (by 13.9 and 35.4 percent higher than in the first quarter of 2015, respectively). The gross inflow of loans to the public sector constituted USD 51.7 million, to the private sector – USD 47.0 million. As a result, the net inflow of loans to the public sector amount of USD 32.6 million, meanwhile, the net outflow from the private sector amounted to USD 46.6 million.

In the reporting period, the volume of accounts payable of resident entities decreased by USD 16.3 million. In general, the prevailing specific weight in the total volume of accounts payable fell on the enterprises of mining and manufacturing industry, and the organizations that deal with wholesale and retail trade.

The negative balance of **portfolio investments** constituted USD 9.0 million due to increase of the residents' investments in the foreign securities. In general, funds were used for purchase of the bonds and other debt securities.

Thus, according to the results of the first quarter of 2016, **the overall net balance of payments** was formed negative in the amount of USD 240.6 million.

The balance of the item "**Errors and omissions**", taking into account the additional estimates of the National Bank of the Kyrgyz Republic, was formed negative in the amount of USD 3.3 million, which proves insufficient statistic recording of transactions related to the outflow of capital to the country or import of goods and services.

The volume of the international reserve assets<sup>12</sup> as of March 31, 2016 constituted 1,741.9 million, which covers 4.4<sup>13</sup> months of the future import of goods and services.

### **Table of the Balance of Payments of the Kyrgyz Republic According to the 6<sup>th</sup> Edition of the Balance of Payments and the International Investment Position Manual**

Currently, the balance of payments statistics is compiled by the National Bank of the Kyrgyz Republic in accordance with the requirements of the Balance of Payments Manual worked out by the International Monetary Fund, the fifth edition (IMF, 1993). However, in order to meet the new international standards, the National Bank takes measures on compiling the external sector statistics based on the IMF new methods - the Balance of Payments Manual, the sixth edition (hereinafter referred to as the BPM 6).

This box provides the users with a preliminary version of the analytical form of the balance of payments of the Kyrgyz Republic for 2015 compiled based on the BPM 6 methods.

Given that the BPM 6 maintains succession with the methods of the fifth edition, the balance of payments statistics, which are based on the methods of the fifth edition, generally, remain comparable with the data compiled based on the new methods. At the same time, the values of the balance of payments accounts changed as the individual items of the balance of payments were regrouped in accordance with the BPM 6.

The presentation form of the balance of payments statistics, formerly based on the credit (plus) and (minus) debit entries was changed in the provisional version of the balance of payments. The operations on loans and debits are registered with a sign "+" in the current accounts and the capital accounts. Meanwhile, the balance of the corresponding items (goods, services, primary income, and secondary income) is defined as a difference between the loan and debit.

The notions "net acquisition of financial assets" and "net incurrence of liabilities" are used instead of "assets" and "liabilities" in the financial account. Net acquisition of assets is equal to the increase in assets after deduction of the decrease in assets. Net incurrence of liabilities is equal to the increase of liabilities after deduction of the decrease in the liabilities. Change with a sign "+" indicates the increase in the assets or liabilities, and change with a sign "-" indicates the decrease in the assets or liabilities. In accordance with the fifth edition of the Balance of Payments Manual, the increase in the asset was registered with a sign "-", the decrease in the assets – with a sign "+".

Statistical differences (the item "Errors and omissions") are obtained as a residual value that brings into balance the positive or negative balances resulting from summing the operations registered in the balance of payments. A positive value of statistical differences indicates the capital inflows into the country or export of goods, which are statistically unrecorded. A negative value indicates the capital outflows from the country or imports of goods, which are statistically unrecorded.

Full data compiling of the balance of payments and the international investment position in accordance with the BPM 6 methods shall be implemented in 2016-2017.

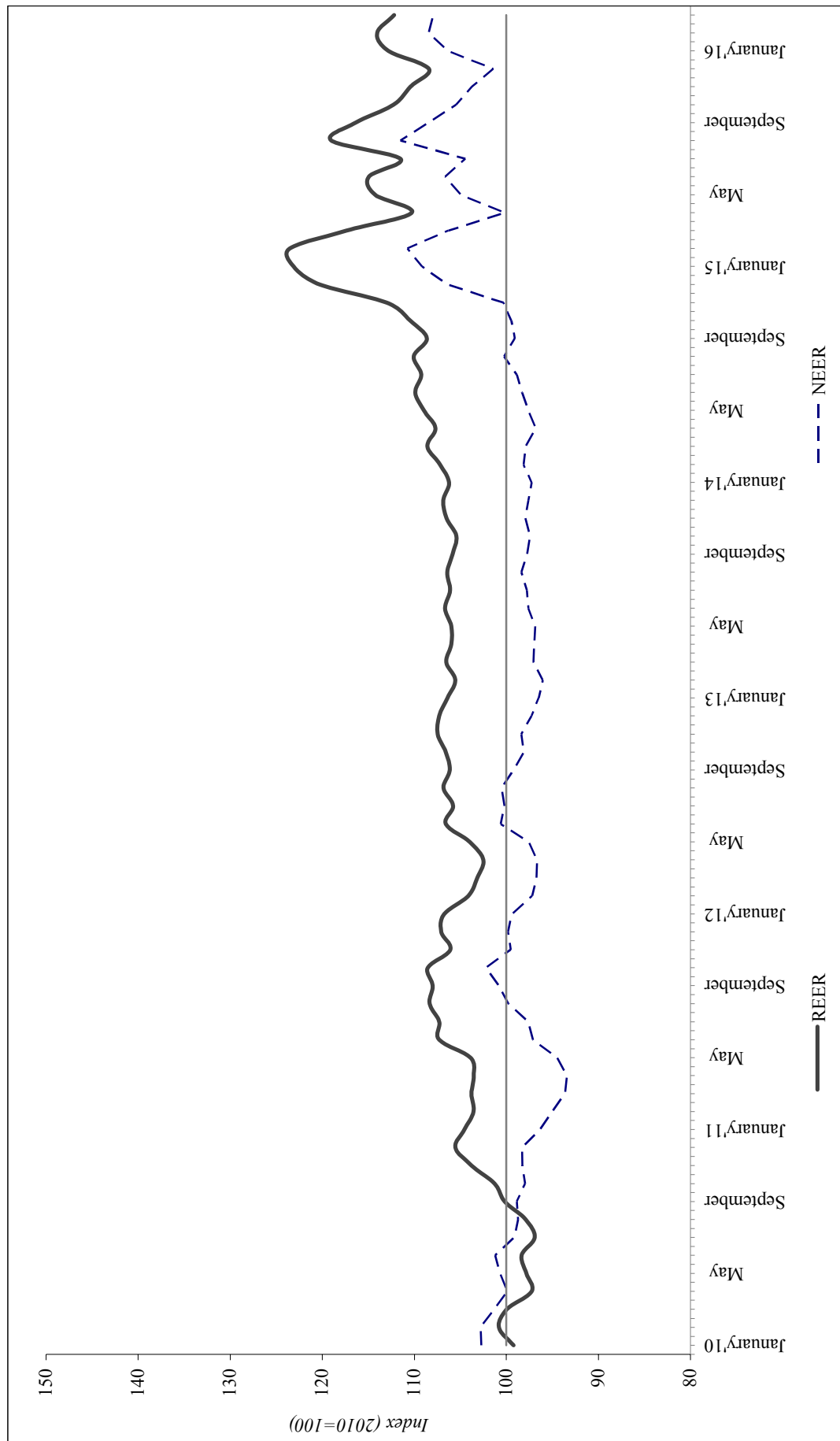
